Candidate Notes

Candidates for this election must be financial members of the Union continuously for two (2) years prior to the close of nominations. Candidates must be members of the branch to which a position relates.

Nominations must be submitted in writing, comply with the rules of the Union and be signed by the nominee and two (2) nominators who are financial members of the Union and members of the branch to which the position relates.

Nominees for Firefighter Branch Executive must be Firefighters usually or ordinarily employed in the branch at the close of nominations. Nominees for Officer Branch Executive must be Officers usually or ordinarily employed in the Branch at the close of nominations.

Candidates may withdraw their nomination not more than seven (7) days after nominations close.

Nominations close at midday on Tuesday, 2 October 2018

Nominations open at midday on Monday, 3 September 2018 and must be received by the Electoral Commission of Queensland by **midday on Tuesday, 2 October 2018**.

Nominations may be received by hand delivery, post, fax or email and must include the signatures of the nominees and nominators. Please ensure that your nomination can be clearly read. A nomination form for this election is provided with this Notice of Election. Forms are also available from the Union and the Electoral Commission; www.ecq.qld.gov.au.

Ballots

Should a ballot be necessary the Commission will conduct a secret postal ballot of the eligible financial members of the branch to which the position relates. If required, these ballot/s will open on Monday, 5 November 2018 and close at **midday Wednesday**, 21 November 2018. In accordance with the Union rules, the ballot will be decided by the optional preferential system of voting.
