Candidate Notes

Candidates nominating for the office of Delegate must be a financial member who has, for the two (2) years prior to the closing date of nominations, been continuously financial or a Life Member working in a Calling. Candidates nominating for the office of Executive must be a financial member who has, for the three (3) years prior to the closing date of nominations, been continuously financial or a Life Member working in a Calling. Candidates must be a member of the Region and hold a position to which a position relates.

Nominations must be submitted in writing, comply with the rules of the Union and be signed by the nominee and two (2) nominators who are financial members of the Union and members of the Region to which the position relates.

Candidates may withdraw their nomination not more than seven (7) days after nominations close.

Nominations close at midday on Thursday, 4 March 2021

Nominations open at midday on Thursday, 4 February 2021 and must be received by the Electoral Commission of Queensland (ECQ) by **midday on Thursday, 4 March 2021**.

Nominations may be received by hand delivery, post, fax or email and must include the signatures of the nominees and nominators. Please ensure that your nomination can be clearly read. A nomination form for this election is provided with this Notice of Election. Forms are also available from the Union and the ECQ's website; www.ecq.qld.gov.au.

Ballots

Should a ballot be necessary the ECQ will conduct a secret postal ballot of the eligible financial members. If required, these ballot/s will open on Thursday, 25 March 2021 and close at **midday on Thursday, 22 April 2021**. In accordance with the Union rules, the ballot will be decided by the optional preferential system of voting.
