A ballot for protected industrial action will be sent to your home address in the next two weeks. This could be one of the most important ballots you will complete.

To take protected action members will need to return more than 50% of the ballots sent out and the "yes" vote needs to be 50% plus 1.

This is your chance to show the fire service and the government that you will not accept these demands to strip away your conditions of employment.

If the required amount of ballot papers are <u>not</u> returned the QFRS and Government will say that they now have a mandate to do as they please.

Eligibility to Vote

An employee is eligible to have their name included on the roll of voters, if the employee will be covered by the proposed certified agreement to which the ballot relates, and if on **8 August 2012**, the employee was employed by the Department of Community Safety under the Queensland Fire and Rescue Service Award - State 2012 as a Fire Fighter (Recruit, Fire Fighter, 1st Class, Senior, Leading) and Station Officer (1, 2, 3 and Building Approval Officers) and are members of United Firefighters' Union of Australia, Union of Employees, Queensland.

Voters Roll

The Commission will receive a list of eligible employees from both the employer and the union. A roll of voters will be compiled by matching the data on both lists provided. Those employees whose names appear on both lists will be included on the roll of voters and will receive ballot material.

The lists will be confidential to the Commission and are not publicly available.

If you believe you are entitled to vote in the proposed ballot and wish to confirm whether your name is included on the roll of voters, contact the Returning Officer prior to **4:00 pm on Thursday, 6 September 2012** to confirm your status. An employee may ask the Commission to add or remove their name from the roll of voters. Additions or subtractions to the roll of voters can be made up until this date.

Ballot

The Commission will conduct a secret postal ballot. The ballot will open on Friday, 7 September 2012. Completed ballot papers must be returned to the Commission by the ballot closing time of **12:00 noon on Friday**, **21 September 2012**. Only ballot papers received by the Returning Officer by this time will be counted.

Ballot material will be posted to the address stated on the roll. If an employee, entitled to vote, will be at an address other than the address stated on the roll when ballot material is posted, they may provide written notice of an alternate postal address to the Returning Officer.

If ballot material is not received, lost, destroyed or spoilt, a voter may apply to the Returning Officer for a duplicate of the ballot document.

In support of reaching an Enterprise Agreement with the Department of Community Safety do you wish to organise and/or engage in separately, concurrently and/or consecutively, the following protected industrial action against the Department of Community Safety?

- 1. An unlimited number of bans of varying duration on the performance of work, by all or part of the workforce (but not bans on the performance of, the processing of, and responding and mobilising resources to 000 emergency calls; fire calls; primary alarm activations and turnout notifications)?
- 2. An unlimited number of limitations of varying duration on the performance of work, by all or part of the workforce (but not limitations on the performance of, the processing of, and responding and mobilising resources to 000 emergency calls; fire calls; primary alarm activations and turnout notifications)?
