Nominations open on **FRIDAY 2<sup>ND</sup> NOVEMBER, 2012**, and will close at 5:00pm on **MONDAY 19<sup>TH</sup> NOVEMBER, 2012**.

**PLEASE NOTE THAT ALL NOMINATIONS MUST BE LODGED WITH THE AUSTRALIAN ELECTORAL COMMISSION, NOT THE UNION, AND NOTE THE OPENING AND CLOSING DATES CAREFULLY.**
